## Is it the license you need?

If part of your business is applying herbicides (including Roundup) or certain pesticides to plant beds, the State of Florida requires that you have a limited pesticide license. Operating without one could mean a \$5,000 fine. Even more, it could increase your liability in case of an accident.

To get licensed, you need to take an 6-hour course and a written exam. But, if you're like many people, taking the time and money to go through the course, especially if you are uncomfortable with taking the exam, is really difficult. So, you put it off, again and again.
